## I. Attendance and Introductions

The meeting was called to order by President Tom Parshall at 7:30 p.m.

## II. Approval of minutes from May 10th meeting.

Janet Frick made a motion to accept the minutes, which had been recorded and processed by Hildy Foley due to Janet Frick's absence at the May meeting. Diana seconded the motion, motion carried.
